### **MINUTES**

The Chair noted that Peter Aucoin sent his regrets as he was unable to attend the meeting for health reasons.

### Agenda

1. Approval of Minutes of Meeting of February 19, 2010

The minutes of the previous meeting were approved.

2. Update on CAPPA-TBS Professional Competencies project

The Chair briefed members on the project, co-sponsored by CAPPA and the Chief Human Resources Officer at Treasury Board Canada, to review the professional competencies expected of Masters-level recruits to the federal government in policy-related positions. The kick-off meeting for this project, co-chaired by Ian Clark (CAPPA) and Daphne Meredith (TBS) was held in Ottawa on May 4, 2010. A follow-up teleconference meeting of CAPPA directors, TBS and the Canada School of Public Service is scheduled for 2:00 to 3:30 pm EST on February 24, 2011 to discuss this project and plans for a potential CSPS/University Symposium in 2011. This project is described in more detail in the paper referenced in the next agenda item.

3. Update on CAPPA Academic and Professional Content Review (Clark-Pal paper)

The Chair described the recent additions to the rolling draft of the paper, entitled "Academic Respectability Meets Professional Utility: Canadian MPA/MPP Programs and Professional Competencies," including the results to date of the work on the CAPPA-TBS Professional Competencies project.

He noted that the curriculum content of Canadian programs of public policy and public administration can be organized using the following set of "generic subjects" listed in Exhibit 7 in the paper:

### 4. Accreditation Review for Johnson-Shoyama

The Board discussed potential candidates for the Accreditation Committee for the Johnson-Shoyama Graduate School of Public Policy. It was decided to improve the age and gender balance of the selection potential pool by approaching faculty members at the Associate Professor level. One Board member undertook to do this and it was agreed to finalize the Review Committee for Johnson-Shoyama in the coming weeks by e-mail, or by another teleconference call if that proved necessary.

It was also agreed that the Accreditation Committee for Johnson-Shoyama would be provided with a copy of the Clark-Pal paper describing the curriculum content of programs in other schools.

#### 5. Future Accreditation Reviews

A brief discussion was held on the state of discussions with the institutions that were logical candidates for accreditation reviews following Johnson-Shoyama. It was noted again that, from an institution's perspective, the most attractive time for a CAPPA review would be when the institution had another review scheduled to comply with university or provincial policy.
