JUDGES



Noah Morris (Head Judge) is Principal at NJM Strategies, a consulting practice that specializes in postsecondary education, public sector financial services and strategic planning. Noah is a recent retiree after 34 years in the Ontario Public Service, most of which was served at the Director and Assistant Deputy Minister level. Noah's career was evenly spread between years of service in Treasury and Finance, and 15 years dealing with every aspect of postsecondary education in Ontario. This included roles as Superintendent of Colleges, Director of Student Financial Assistance, Director of Postsecondary Finance and ADM of Postsecondary Education in the Ministry of Colleges and Universities. Noah was also the Chair of the Federal-Provincial committee on postsecondary student finance (ICCSFA) for many years. Noah's last role in Ontario was ADM - Enterprise Financial Services, where he led implementation and delivery of over 25 COVID support programs. Noah is the recipient of 2 personal Amethyst awards for signature public policy achievements in Ontario. Noah holds a B.A. from McGill, and an MPI from Queens.



Suzanne Craig has more than 30 years of legal, governance and policy development experience in the public and private sectors. She has been an arbitrator and mediator. As an internationally trained lawyer, Ms. Craig practiced corporate commercial law and worked as a forensic investigator in the European banking sector. First appointed as Integrity Commissioner for the City of Vaughan in 2009, Ms. Craig has served as Integrity Commissioner, Lobbyist Registrar (City of Vaughan) and Closed Meeting Investigator to over 30 Ontario municipalities. In addition to having served from 2016 to 2021 as the first appointed Integrity Commissioner to the Toronto District School Board, Ms. Craig is currently the Integrity Commissioner for the Ottawa-Carleton District School Board and the York Region District School Board.



Nancy Carroll has a Bachelor of Arts Honors (University of Manitoba) and a Bachelor of Laws (Dalhousie University). Nancy joined the Manitoba government as a management intern. Over the following 2 decades Nancy worked in numerous government departments in progressively responsible positions. Her final position in the Manitoba government was serving as the Civil Service Commissioner with responsibility for human resource service delivery to all government departments. Since leaving the Manitoba government, Nancy joined Red River College Polytechnic, providing strategic labour relations advice.



Stefania Trombetti is the Executive Director of the Regulatory Governance Initiative and Instructor for the Career Development for Regulatory Professionals Program in the School of Public Policy and Administration at Carleton University. Stefania had a 35-year career in Canada's federal public service, serving in policy and regulatory roles across five departments. Before retiring in 2024, she led federal policy and regulatory initiatives to improve supply chain resilience for health products as Assistant Deputy Minister of Health Canada's Drug Shortages Task Force. Prior to that, she was Assistant Deputy Minister of the Regulatory Operations and Enforcement Branch at Health Canada, overseeing compliance and enforcement programs for all products regulated by the department and responsible for coordinating the department's regulatory agenda and managing drug and medical device shortages. Stefania is a graduate of Queen's University (M.A., Political Studies) and of the University of Ottawa (Bachelor of Social Sciences, Political Science with a Minor in Italian Studies).



Guy Giorno leads his firm's Political Law practice, advising on lobbyist registration, government accountability, ethics, public-sector conflict of interest, and procurement. He represents corporate executives and lobbyists in enforcement proceedings and helps organizations develop compliance strategies. A recognized expert, he has testified before parliamentary committees on lobbying law and has advised multiple provinces on lobbyist registry design. Previously the Lobbyist Registrar for Brampton, he now serves as Integrity Commissioner for several Ontario municipalities, overseeing ethics compliance. His work in freedom of information law includes advising public institutions and assisting individuals in accessing government records. Guy is the co-author of *Lobbying in Canada* and a former Chair of the Canadian Bar Association's "Law of Lobbying and Ethics" Committee.



Michael Presley is currently adjunct professor, School of Public Policy and Administration and co-director of the Career Development for Regulatory Professionals program. He is also director of the certificate program in regulatory leadership at the Centre for Public Management and Policy (Odell House) at the University of Ottawa. Before joining the University of Ottawa, he was Assistant Deputy Minister (Regulatory Affairs) at the Treasury Board Secretariat between 2009 and 2014. Prior to that, he spent 15 years at Agriculture and Agri-Food Canada, notably occupying various functions: Director General of the Food Value Chain Bureau, Director General of the Food Bureau and Director of the Environment Bureau. A leading expert in regulatory affairs, Mr. Presley has worked closely with the private sector on many government-led initiatives.
